1. Introduction

This document introduces the Comprehensive Peace Agreements Implementation Dataset (CPA_ID), which contains qualitative and quantitative data on thirty-four negotiated, written and publicly available comprehensive peace agreements between the main parties to the conflict, at least one of which is the government controlling the capital of the state, aimed at ending intrastate conflicts between 1989 and 2012, addressing the core issues underlying the conflict.

The unit of observation in the dataset is intra-state comprehensive peace agreement cases. There are 85 indicator variables, disaggregated into five categories of concepts, to be assigned to each case. These concepts are: (a) power sharing, (b) transitional justice, (c) transitional reform, (d) international assistance, (e) implementation process.

CPA_ID is an output of the project numbered '122G203' and titled 'Order and Justice after the Comprehensive Peace Agreement In Ending Intra-State Conflicts: A Configurational Comparative Analysis of Thirty-Four Peace Processes (1989-2012)' supported by TUBITAK Academic Research Funding Programmes Directorate (ARDEB) within the scope of '3005 - Innovative Solutions Research Projects Support Program in Social Sciences and Humanities'. The dataset has been created not only to be used within the scope of the project, but also to provide a dataset of theoretical and practical importance to researchers and practitioners (facilitators, mediators, etc.) working in the field of Peace and Conflict Studies. Users can browse, compile and export agreement provisions relevant to their research.

The project team is responsible for the content of the dataset.

2. Key Definitions

Conflict: a situation in which deaths occur as a result of the use of armed force between at least two rival parties who disagree on the subject in dispute.

Dispute: a disagreement of views or interests on a particular issue between at least two parties.

Rival party: those who oppose each other in trying to achieve a result in their favour on any issue.

Use of armed force: violence by any material means.

Intra-state conflict: political violence between the government and at least one rebel/opposition group within the territory of a state, related to government and/or territory in which at least 25 people are killed as a result of the use of armed force in a calendar year.

State: the sovereign power that controls a territory and is recognised by other states.

Government: the party assuming the administration of the state and controlling its capital.

Rebel/Opposition Organisation: any non-governmental group of people that declares a name for itself and consciously, deliberately uses armed force.

Governmental dispute: a dispute over the structure and components of a political system, regime or centralised government.

Territorial dispute: a dispute over the status or ownership of a territory.

Peace process: a multilateral and multidimensional process of action between conflicting parties, including peacekeeping, peacemaking and peacebuilding, involving a variety of activities aimed at achieving sustainable peace.

Peace agreement: a written and publicly available document mutually agreed/signed by at least two rival conflicting parties to end the conflict in which all or some of the issues in dispute are resolved through negotiation.

Comprehensive peace agreement: a written and publicly available document between the main parties to a conflict, mutually agreed/signed with a view to ending the conflict, in which the substantive issues underlying the conflict are resolved through negotiation.

Comprehensive intra-state peace agreement: a written and publicly available document between the main parties to an intra-state conflict, mutually agreed to/signed with a view to ending the conflict, in which the substantive issues underlying the conflict are resolved through negotiation.

4. Data Sources

Primary and secondary, qualitative and quantitative data sources were used for data collection.

Data on thirty-four variables related to the concept categories of power sharing, transitional justice, transitional reform and international assistance were obtained from the texts of the agreements downloaded from the United Nations Peacemaker Peace Agreements Database (<https://peacemaker.un.org/document-search>).

Data on fifty-one variables related to the implementation process concept category were transferred from the Peace Accords Matrix Implementation Dataset (PAM_ID) (<https://peaceaccords.nd.edu/>). This dataset contains qualitative and quantitative data on the extent to which fifty-one defined provisions in comprehensive intrastate peace agreements have been implemented in the ten years following the signing of the agreement.

Data on armed conflicts and conflict-related deaths were transferred from the UCDP/PRIO Armed Conflict Dataset and the UCDP Georeferenced Event Dataset (GED).

The data sources utilised for other descriptive variables are as follows:

- 1) PAIC, Political Agreements in Internal Conflict Dataset, (<https://edata.bham.ac.uk/581/>):
This dataset contains detailed coding and information on 290 political agreements between 1989 and 2016.
- 2) PA-X, Peace Agreements Database and Dataset (7th version), (University of Edinburgh), (<https://www.peaceagreements.org/>):
This database is a repository of peace agreements from 1990 to the present (to 2023).
- 3) UCDP Peace Agreement Dataset (version 22.1), (Uppsala Conflict Data Programme), (<https://ucdp.uu.se/downloads/index.html#peaceagreement>):
This dataset contains 374 peace agreements signed between at least two opposing primary warring parties in an armed conflict between 1975 and 2021.

5. Coding Procedure

CPA_ID contains 85 indicators and 171 sub-indicator variables for each case. These indicators are categorised around five concepts. The coding procedure for each concept category consists of five stages. These are; (1) conceptualisation, (2) systematisation, (3) operationalisation, (4) assigning indicators, (5) case coding.

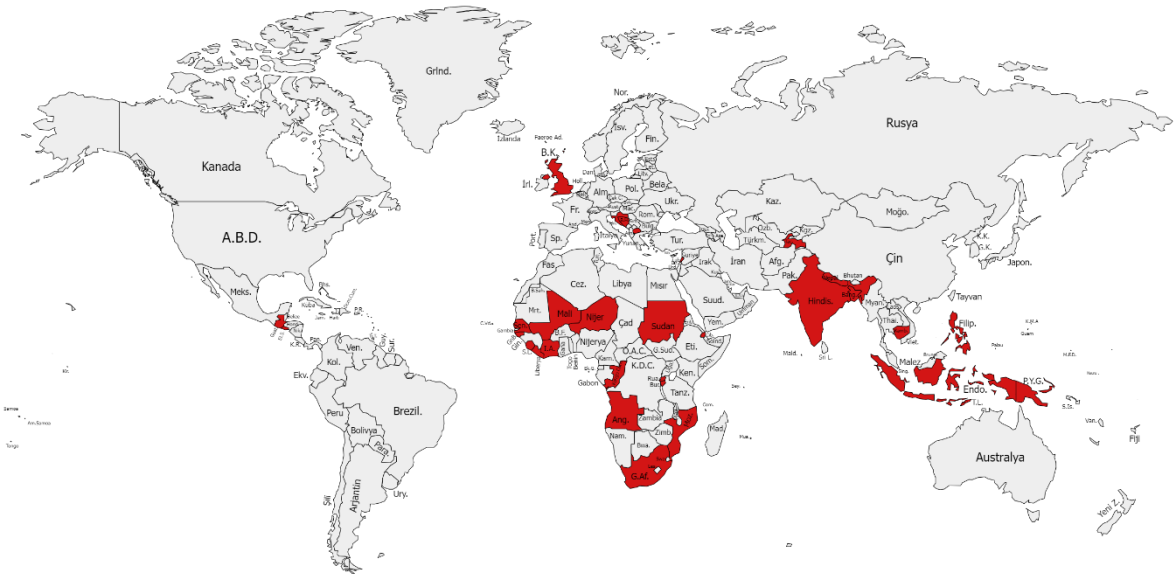

Appendix 1: Case Population

The selection criteria for the case population are as follows

- i. signed between 1989 and 2012,
- ii. aiming to end intra-state conflict,
- iii. address the substantive issues underlying the dispute,
- iv. signed between the main parties to the conflict, at least one of which is the government controlling the capital of the state,
- v. signing by negotiation,
- vi. mutual acceptance,
- vii. written and publicly available.

The year 1989 was set as the beginning with reference to the post-Cold War period and the year 2012 was set with reference to 2022 as the ten-year implementation period will be analysed in each post-agreement period. In addition to these criteria, an important issue is the need to collect data on the implementation process condition. A study on this issue in the literature was conducted by the Kroc Institute for International Peace Studies at the University of Notre Dame. PAM_ID has been made available to researchers as the Peace Accords Matrix Implementation Dataset (<https://peaceaccords.nd.edu/>). This dataset contains detailed coding and information on the implementation of the agreement provisions over a ten-year period. Due to the availability of data on the implementation process, it was decided to include the peace agreements in the PAM_ID Dataset in the case population. After searching the UN Peacemaker Peace Agreements Database (<https://peacemaker.un.org/document-search>), a total of 34 cases out of 547 political agreements were included in the population, of which one was an interim constitution and 33 were peace agreements. Below is a map of the location of the countries included in the case population, where an intra-state conflict took place and a comprehensive peace agreement was signed, and a table with information on the CPA_ID identifier number and label, country, agreement name and date of signature for each case.
